

Terms of participation

- 1 Every participant must read these terms of participation before entering the Hornpark. With his signature, the participant confirms that he has read these terms of participation and agrees to them. For underage participants, a legal guardian must read these terms of participation and discuss them with the minor before they are allowed to use the course.
- 2 Climbing in the Hornpark is dangerous and occurs at the participant's own risk. The participant acknowledges that incorrect use of safety technology can result in serious injury or death, and that injuries of all kinds are to be expected when attempting the course. Additionally, depending on the season, tree sap can be released, which may stain clothing.
- 3 The maximum body weight for participants is 120 kg. Mini course: 3-6 years & 100-120 cm. Yellow, Green & Orange: 110 cm. Blue, Red 1 & 2: 140 cm. Flying Fox: minimum 40 kg - maximum 90 kg. The minimum height, minimum age, and additional requirements for the different courses can be found on the course information board.
- 4 The participant declares that they do not suffer from any physical or mental illnesses that could pose a danger to themselves or others, and that they are not under the influence of alcohol or drugs. Pregnant women are not permitted to climb.
- 5 Children under 14 years of age may climb only with a companion (aged 16 or older). The companion must climb ahead of the children in the course and support them while climbing. A maximum of 3 children per adult is allowed.
- 6 No items that could pose a danger to the participant or others (e.g., backpacks, scarves, jewelry, phones, cameras, etc.) may be carried while on the course. Long hair must be tied back. Sturdy footwear is required for accessing the Hornpark. The management reserves the right to deny entry to participants wearing inappropriate clothing (e.g., sandals, flip-flops). Gloves are mandatory.
- 7 The equipment provided (helmet, climbing harness, safety line with carabiner, and steel pulley) must be used according to the guide's instructions. The equipment is non-transferable, may not be removed during your time in the park, and must be returned to the staff afterwards. Once returned, there is no possibility to reissue the equipment. The climbing harness will be checked by a guide before climbing.
- 8 Every participant must attend the safety briefing before accessing the Hornpark and complete the training course under the supervision of the staff. All instructions and decisions of the organizer/guide are binding. Participants who violate the instructions or safety requirements of the guide may be excluded from the Hornpark. In such cases, Hornpark GmbH assumes no liability for any resulting damages.
- 9 The safety line carabiner must be clipped onto the steel cable at the starting point (ground level). The autolock carabiner should be attached to the steel cable marked with a red indicator. The pulley must be clipped onto the steel cable marked with a green indicator. At the beginning of the course, the fall arrester must be used. Before starting the zipline, ensure that both the line and the landing area are clear!
- 10 Each element may be used by a maximum of 1 person at a time. A maximum of 3 people are allowed on the platforms at the same time.
- 11 In the case of self-inflicted incidents, such as not adhering to age or weight restrictions or committing serious errors, a rescue will cost 15 euros.
- 12 The management reserves the right to exclude individuals who do not adhere to these usage rules from the park. The management also reserves the right to close the park for safety reasons (e.g., fire, storm, thunderstorm). In such cases, no refund of the admission fee will be provided. If a guest terminates their visit to the Hornpark early for personal reasons, no refund of the admission fee will be given.
- 13 The participant agrees that photos and videos in which they are recognizable may be used by Hornpark GmbH for promotional purposes. This consent can be revoked at any time in writing or electronically. Personal data may be shared with the relevant authorities for the creation of necessary documents. Further information on data processing is available upon request.
